CODE OF ETHICS

FOR ANYONE SEEKING TO WORK WITH MINORS AT CALVARY BAPTIST CHURCH

While serving in any ministry involving minors, and when in the presence of minors, the following shall apply:

- All people of any race, religion, culture and/or disability must be treated with respect and consideration.
- Be a positive role model by maintaining an attitude of respect, loyalty, patience, courtesy, and maturity.
- Act and react with Christian love and understanding in all situations.
- Avoid being put in a situation where you are alone with a minor other than your own.
- You must be free of any physical and/or psychological conditions that might adversely affect any minor's health including, but not limited to, serious contagious disease.

While serving in any ministry involving minors, and while in the presence of minors, **<u>the following are</u> <u>prohibited and will not be tolerated</u>:**

- Smoking or using tobacco products, the use or possession of alcohol, being under the influence of alcohol, the use or possession of illegal or illicit drugs; being under the influence of illegal or illicit drugs.
- Any display, demonstration, observation, insinuation or evidence of sexual activity, sexual advances or sexually abusive conduct of any kind.
- The presence or possession of obscene or pornographic materials.
- Infliction of abuse or intentional injury, i.e., physical, mental, emotional or bodily.
- Physical neglect including failure to provide adequate supervision.
- The use of profanity.

I understand that to work with minors in Calvary Baptist Church any violation of this Code of Ethics may be grounds for removal of my capacity to work with minors and could result in disciplinary and/or legal action.
